4 types of corporations - Correct Answers -sole proprietorships
partnerships
limited liability companies
corporations

characteristics of a sole proprietorship - Correct Answers -owned and run by one person
easy to set up
no separation between firm and owner
owner has unlimited personal liability for any of the firm's debts
life of firm is limited to life of owner
examples = housecleaner, tutor

characteristics of a partnership - Correct Answers -more than one owner
all partners are liable for firm's debt
ends with death or withdrawal of any single partner

2 types of partnerships - Correct Answers -general and limited

General Partnership - Correct Answers -partnership in which partners share equally in both responsibility and liability, unlimited liability

advantages and limitations to multiples - Correct Answers -advantages - embeds estimates of discount rates and growth rates, market prices may capture other missing variable, helps free ride a market's research capabilities, QUICK
disadvantages - comparable can be difficult to find, what if entire industry is overvalued/

how to value a firm? - Correct Answers -discounted free cash flow model
what are expected cash flows? - to all investors (debt and equity holders)
what is proper discount rate? - consider cost of capital for both debt and equity

what is free cash flow? - Correct Answers -cash flows that are available to ALL investors (both debt holders and equity holders) after all investment needed for operations and growth (unlevered FCF, no debt, separate from any financing decision)

limited partnership - Correct Answers -partnership in which only one partner is required to be a general partner - limited liability for firm's debt, stops at the amount you invested (example, PE or venture capital)
