- 1. Establish compliance standards and procedures
- 2. Assign top level management overall responsibility for compliance
- 3. Don't delegate responsibility to employees who are not trustworthy
- 4. Communicate standards and procedures to all employees
- 5. Monitoring and audit systems used to detect unethical activities
- 6. Enforce ethical standards through appropriate disciplinary mechanisms
- 7. Make adjustment to ethical process if unethical behavior has occurred
